Prince of Songkla University

Postdoctoral Fellowship of Fiscal Year 2022-2023

In order to enhance research capacities, particularly in the area of infectious diseases and cancer research to increse international publications and supporting operations of global and frontier university, PSU has established a postdoctoral fellowship with the following criteria:

1. Terms

- "University" refers to Prince of Songkla University (PSU)
- "Fellowship" refers to the fund to support a PSU postdoctoral fellow
- "Committee" refers to Postdoctoral Fellowship Administration Committee
- "Supervisor" refers to a PSU professor who provides guidance to a postdoctoral fellow
- "Postdoctoral fellow" refers to a researcher who has completed Ph.D.
- 2. The Fellowship

The university has allocated a budget from the reinventing university program to support a research fellowship with a monthly salary of 50,000 baht in one year.

- 3. Supervisor must be a PSU staff with following qualifications:
 - 3.1 Has completed a doctoral degree or equivalent.
 - 3.2 Has in-depth experiences and research projects.
 - 3.3 Is currently conducting a research project with sufficient funding to support the postdoctoral fellow.
- 4. Applicant must have the following qualifications
 - 4.1 Not over 45 years in age.
 - 4.2 Is a Thai or foreign researcher who holds a doctoral degree (Ph D).
 - 4.3 Has at least 2 research articles published in Web of Science.
 - 4.4 Is able to work full time as a postdoctoral fellow.
 - 4.5 Is currently not receiving any postdoctoral fellowship from any other domestic or international institution.

5. Conditions

5.1 The supervisor has the responsibility to advise the postdoctoral fellow to successfully conduct the proposed research in accordance with the conditions of this fellowship.

- 5.2 The postdoctoral fellow has the following responsibilities:
 - 5.2.1 The contract with the university is on a yearly basis.
 - 5.2.2 Submit a progress report or a manuscript every 6 months, starting from the signed contract date. Failure to comply may result in discontinuation of the funding.
 - 5.2.3 To be the first author of at least one research article published in an international journal publication during the fellowship and the corresponding author of the article must be the supervisor. The published article's acknowledgement must include following sentence or an equivalent form "This research was supported by Prince of Songkla University under the Postdoctoral Fellowship Program".
 - 5.2.4 Other duties assigned by the supervisor.
- 5.3 Performance of the postdoctoral fellow will be evaluated every 6 months by the supervisor and the Postdoctoral Fellowship Administration Committee. Failure to pass the evaluation may result in termination of the fellowship.
- 5.4 Intellectual properties and other benefits produced from the research during the fellowship must be handled under the university IP regulations.
- 5.5 Decision made by the Postdoctoral Fellowship Administration Committee shall be regarded as final judgment. Any appeal will not be considered.
- 6. Application
